Observations

- Walk through of the end-to-end approval, import clearance and logistics processes was invaluable for the Lead Team
- Agency coordination and understanding for the regulatory requirements enhanced and enabled quick mobilization for expedited clearance of the first consignment of covid vaccines (completed within 3 hours)
- Fact Sheets for Commercial Importers and Private Importers will be useful for donors
- Consultation further enhanced the engagement that was commenced during the development of the TFA Roadmap.

To further the Government of Tonga's goal to facilitate compliant and legal trade and to stop the importation of unsafe and "fake" medicines, therapeutics and pharmaceutical INTRODUCTORY PRINCIPLES

Bringing goods such as medicines, vaccines, veterinary medicines, therapeutics and pharmaceuticals into Tonga from overseas is called 'importing' and there are specific rules associated with importing that must be followed for all imported goods.

In general, goods are defined under the law as "includes excisable goods, documents, tangible personal property, commercial cargo, currency, livestock, motor vehicles, arcraft and ship's stores, accompanied and unaccompanied baggage, aircraft and ships, including self-transported ships and arcraft." Any good that comes from outside the Kingdom of Tonga into Tonga are considered 'imported' regardless of whether the good or goods are;

- Gifts, donations or purchased
- Intended for testing or intended for sale Samples or commercial lots
- Arrive in Tanga via airfreight, seafreight, express courier or Legal or ∎egal

The person or company or organisation who is receiving the imported goods is the importer and the importer is liable, for example, for wrong information given to the border authority or importing any illegal goods or errors and omissions on the customs declaration.

All imported items must be degred through Customs What are commercial goods?

Commercial goods are any items you are going to sell or use in your business. Commercial goods include samples. Legal Basis for Importing and Exporting

The Pharmacy Act 2004 and the Therapeutic Goods Regulations 2011 establishes the legal framework for the importation and exportation of medical drugs in Tonga. 11 Pay freight and storage

The Customs and Excise Management Act 2017, Customs regulations, policies and Procedures impose controls over the physical importation and exportation of medical drugs. Procedures anguse curious over the physical impartional and experional of medical and the Customs law also contains powers for the detention, analysis and seizure of fake or counterfeit drugs suspected to be imported illegally. Check Before You Import

Before you import or export check to verify if the goods can be imported into Tonga and whether there are approvals, restrictions, or special conditions relevant to the goods. Medicines, Vaccines, Therapeutic and Pharmaceutical Goods

Some medicines, vaccines, therapeutics and pharmaceutical goods are controlled goods which means the import of the items could be prohibited or subject to restrictions or

Although some medicines, therapeutics and pharmaceutical goods are available locally this does not automatically allow you to import those same items. There may be conditions, regulations and approvals that must be met before the goods can be imported.





Lessons Learned

- Establishing a small multi-agency lead team was a key success factor
- Establishing a structured schedule of working group sessions with outcomes for each activity ensured focus
- Ministry of Health were key participants and identified improvements within their agency
- Physical walk through and observation of each border organisation process identified points of connection for improved coordination and a real understanding of the logistics procedures to support timely delivery of vaccines
- Private sector requested published procedures for clearance and contact points — this led to the development of the Fact Sheets
