The Trade Facilitation Agreement (TFA) entered into force on 22 February 2017 when the WTO obtained the two-thirds acceptance from its 164 Members.



European Union ratification: For the purposes of calculation of acceptances under Article X.3 of the WTO Agreement, an instrument of acceptance by the European Union for itself and in respect of its Member States shall be counted as acceptance by a number of Members equal to the number of Member States of the European Union which are Members to the WTO.

NOTIFICATION DEADLINES





- 84% of LDCs (26 Members) that have designated category B commitments, have also notified their category B definitive dates before the deadline
- 9 LDCs requested an extension of time until 21/02/2021 to notify these dates:
 - 7 have already provided the dates:
 Afghanistan; Burkina Faso, Chad, Lao PDR, Senegal, Sierra Leone and Solomon Islands.
 - 2 Members have not yet notified these dates:
 Djibouti and Mauritania.





Out of the 32 LDC Members that have notified Category C designations to date:

- 29 Members have already notified category C indicative dates.
- 3 Members have not yet done so:
 - Djibouti, Myanmar and Rwanda





Out of the 32 LDC Members that have notified Category C designations to date:

- 5 Members have notified Donor arrangements:
 - Bangladesh, Cambodia, Madagascar, Mali and Niger.
- 27 Members have not yet done so.








Timeline of implementation commitments






Rate of TFA implementation commitments Timeline
