The training will also include identification of type of information that the agencies need to publish;

• Technical Assistance in developing a Trade Portal which would encompass a functioning website for the Department of Trade; this would provide a centralized point for publication of relevant laws and regulations. Also capacitate other border agencies with access as well as knowledge of how to properly use this publication platform;

• Technical Assistance and Capacity Building to review existing legislation:

Identify and allocate resources to ensure timely publication;

Develop and implement change management programmes in the public sector to effectively disseminate information;

Develop public education content and campaigns, and develop standard operating procedures (SOP); and

Setup the central body to monitor and coordinate the dissemination of information, as well as the adoption of best practices.


