The following communication, dated 20 February 2018, is being circulated at the request of the delegation of Thailand for Members' information.

Pursuant to Article 16.1(b) of the Agreement on Trade Facilitation ("the Agreement"), the Royal Thai Government has the honour to notify the Committee on Trade Facilitation of definitive dates for the implementation of the provisions Thailand has designated as Category B commitments in the notification G/TFA/N/THA/1 dated 24 May 2017.
